**NOTICE OF TRADEMARK SECURITY AGREEMENT

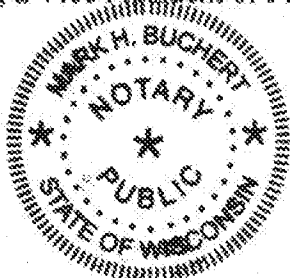


