**ASSIGNMENT AND RELEASE OF

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby notifies, acknowledges and agrees with the Grantor that (i) the security interest granted by such the Grantor in the Trademarks, including, without limitation, the security interest in the trademarks listed on the attached Schedule A (collectively, the "Trademarks Collateral"), is terminated, released and discharged, (ii) the Agent hereby releases and forever discharges all of its right, title and interest of any kind or nature in the Trademarks granted, assigned or conveyed pursuant to the IP Security Agreement, and (iii) any right, title or interest of the Agent in the Trademarks shall hereby cease and become void. The Agent hereby retransfers and reassigns to the Grantor, without representation or warranty, all of the Lender's right, title and interest in and to the Trademarks.


The Lender hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release.
