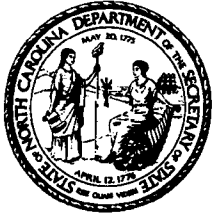

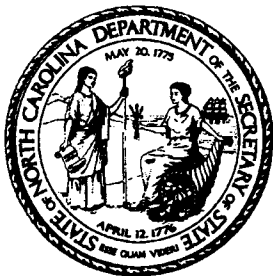

3. The name of the merging entity is Waste Industries Property Co., LLC, a limited liability company organized under the laws of Delaware.


