# ASSIGNMENT

a) conveying party hereby assigns and transfers, without any representation, warranty or recourse whatsoever, its entire right, title and interest in and to the mark, and all goodwill thereof, to receiving party;

b) receiving party hereby: (i) accepts such assignment and transfer; (ii) assumes all duties, liabilities and obligations arising from or relating to the mark and/or such assignment and transfer; and (iii) releases and discharges conveying party, and agrees to indemnify, defend and hold harmless conveying party, from all duties, liabilities and obligations arising from or relating to the mark.

c) This Assignment: (i) shall bind, and inure to the benefit of, the parties and their respective successors and assigns; (ii) shall not be amended except by a writing signed by the party against whom enforcement is sought; and (iii) shall be governed, construed and interpreted in accordance with the laws of the State of Delaware without regard to conflict of laws principles except as necessarily governed, construed and interpreted in accordance with United States federal trademark laws, in which case, such trademark laws shall apply. Provisions hereof are severable, such that, if any shall be held unenforceable, the others remain enforceable. Each party shall from time to time reasonably cooperate to execute and deliver any and all reasonable documents reasonably necessary to further evidence or effectuate this Assignment and all transactions contemplated hereunder.
