4. the right to claim priority.


Assignor does hereby reaffirm that it irrevocably and forever sells, assigns and transfers to Assignee each and all of the above for said consideration.



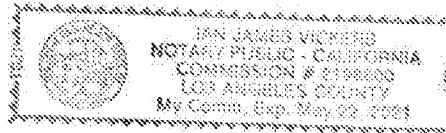

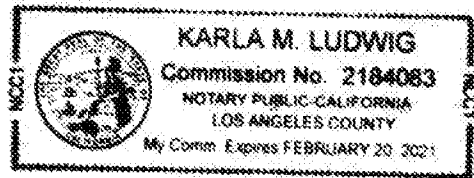
