- FIRST:** The name of the Corporation is NPES The Association for Suppliers of Printing, Publishing and Converting Technologies, Inc. (hereinafter called the "Corporation"). The Corporation was formed under the name of Printing Equipment Association, Inc.
- SECOND:** The Corporation's Certificate of Incorporation was filed with the Department of State on August 22, 1933. The Corporation was formed under the Membership Corporation Law of the State of New York.


