RELEASE OF TRADEMARK SECURITY AGREEMENT

September 20, 2019

**WHEREAS**, LAUREL, JENSEN AND VON, LLC, a Nevada limited liability company (the “Grantor”) entered into that certain Trademark Security Agreement, dated as of November 16, 2017, in favor of MEDLEY CAPITAL LLC, as collateral agent (the “Collateral Agent”), which was recorded with the United States Patent and Trademark Office on November 16, 2017 at Reel 6207, Frame 0040 (the “Agreement”). Capitalized terms used herein but otherwise not defined herein shall have the meanings ascribed to them in the Agreement.

**WHEREAS**, pursuant to the Agreement, the Grantor granted to the Collateral Agent for the benefit of the Secured Parties a security interest in the Trademark Collateral (as defined below), including, without limitation, the trademark identified on Schedule A attached hereto.


**NOW, THEREFORE**, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, without representation, warranty or recourse, hereby terminates and releases its security interest in and Lien on all of the Grantor’s right, title and interest in and to the following Collateral of Grantor: (collectively the “Trademark Collateral”):

- (a) all of its Trademarks and all exclusive Trademark Licenses providing for the grant by or to Grantor of any rights under any Trademark, including the Trademark identified on Schedule A attached hereto;
- (b) all renewals and extensions of the foregoing;
- (c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
- (d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

The Collateral Agent acknowledges that this document may be filed with the United States Patent and Trademark Office to evidence the termination and release granted herein.
