**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL dated as of August 30, 2019 (this "Security Release") is made by BROADWAY CAPITAL CORP., LLC, ("Secured Party") in favor of VOICE MEDIA GROUP, INC. n/k/a VOICE MEDIA GROUP, LLC, by conversion ("Grantor") as follows:

**WITNESSETH**

WHEREAS, pursuant to the Trademark Security Agreement dated January 17, 2013 (the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on January 24, 2013 under Reel/Frame 4948/0554, the Grantor granted the Secured Party a security interest in certain collateral pledged by the Grantor defined collectively therein as the "Trademark Collateral," including, without limitation, the United States trademarks set forth on Schedule A attached hereto; and

WHEREAS, in connection with Grantor's payoff of indebtedness owed by Grantor to Secured Party as of the date hereof, Secured Party is releasing its security interest in all right, title and interest of the Secured Party in and to the Trademark Collateral.

NOW, THEREFORE, the Secured Party hereby terminates, cancels and releases the security interest in the Trademark Collateral, and any and all right, title and interest of the Secured Party in the Trademark Collateral shall hereby terminate, cease and become void.

The Secured Party agrees to provide Grantor with any information and additional authorization and documentation necessary to further evidence and effect the release of Secured Party's security interest in the Trademark Collateral.
