## SUCCESSOR AGENCY AGREEMENT

This SUCCESSOR AGENCY AGREEMENT (this "Agreement") is dated as of July 25, 2019, by and among CORTLAND CAPITAL MARKET SERVICES LLC, a Delaware limited liability company (the "Resigning Agent"), CORTLAND PRODUCTS CORP., a Delaware corporation (the "New Agent"), the lenders party hereto, and SUNGARD AS NEW HOLDINGS III, LLC (the "Company"). WHEREAS, the Resigning Agent is the existing administrative agent under the Credit Agreement, dated as of May 3, 2019, among the Company, as borrower, Sungard AS New Holdings II, LLC, the Resigning Agent and the lenders party thereto (the "Credit Agreement");

WHEREAS, as of the date hereof, pursuant to Section 9.09 of the Credit Agreement, the Resigning Agent hereby notifies the Lenders and the Company of its resignation as Administrative Agent under the Credit Agreement and the other Loan Documents, such resignation to become effective in accordance with Section 2 below;

WHEREAS, the Lenders party hereto, constituting the Required Lenders, desire to appoint the New Agent as the successor Administrative Agent under the Credit Agreement and the other Loan Documents; and

WHEREAS, the New Agent has agreed to accept such appointment and to serve as the Administrative Agent, in accordance with the provisions of this Agreement.

NOW, THEREFORE, the parties to this Agreement hereby agree as follow:

Section 1. Definitions. Unless otherwise defined in this Agreement, capitalized terms used in this Agreement shall have the meaning ascribed to them in the Credit Agreement.

Section 2. Resignation of Resigning Agent. Pursuant to Section 9.09 of the Credit Agreement, the Resigning Agent hereby resigns as Administrative Agent under the Credit Agreement and the other Loan Documents, effective upon the date hereof (the "Effective Date"). On the Effective Date, the Resigning Agent's rights, powers and duties (other than such rights expressly provided herein) as Administrative Agent shall be terminated, without any further act or deed on the part of the Resigning Agent or any of the parties to the Credit Agreement.

Section 3. Waiver. The Company and the Required Lenders hereby waive the notice requirement provided for under Section 9.09 of the Credit Agreement.

Section 4. Appointment of Successor Agent. Pursuant to Section 9.09 of the Credit Agreement, the Lenders party hereto, constituting the Required Lenders, irrevocably designate and appoint the New Agent as successor Administrative Agent to serve as Administrative Agent for all purposes of the Credit Agreement, each of the other Loan Documents, and to take such actions and perform such duties and exercise such powers as are expressly delegated to the Administrative Agent by the terms of the Credit Agreement and each of the other Loan Documents, together with such other powers as are reasonably incidental thereto, and the New Agent accepts such appointment, in each case with effect from the Effective Date.

Section 5. Assignment and Assumption.

(a) As of the Effective Date, the Resigning Agent, as prior Administrative Agent, hereby assigns and transfers to the New Agent, as successor Agent, and the New Agent in its capacity as successor Administrative Agent hereby assumes, all of the rights and obligations of Administrative Agent under the Credit Agreement and each of the other Loan Documents. On and after the Effective Date, the Resigning Agent, as the prior Administrative Agent, shall have no obligations as Administrative Agent under the Credit Agreement or each of the other Loan Documents.

(b) The parties to this Agreement acknowledge and agree that on and after the Effective Date (i) the New Agent, as successor Administrative Agent, shall have all of the rights and benefits of the Administrative Agent under each of the Loan Documents, including, without limitation, the Credit Agreement, the Fee Letter and the Collateral Documents, but shall have no responsibility or obligation or liability in connection with any act or omission of the Resigning Agent, as the prior Administrative Agent, for any period prior to the Effective Date, and (ii) the Resigning Agent shall have no responsibility or obligation or liability in connection with any act or omission of the New Agent, as successor Administrative Agent on and after the Effective Date.

(c) Nothing in this Agreement shall constitute a waiver or assignment of any responsibility or obligation or liability of the Resigning Agent, as Administrative Agent, for any period prior to the Effective Date.

Section 6. Transition of Agent Role.

(a) From and after the Effective Date, the Resigning Agent, as the prior Administrative Agent, shall promptly and reasonably cooperate with the New Agent, as the successor Administrative Agent, in the transition of the Administrative Agent's duties and obligations under the Loan Documents, including, without limitation:

(i) executing and delivering documents reasonably requested by the New Agent, as the successor Administrative Agent, to confirm transfer of the interest of the Resigning Agent, as prior Administrative Agent, to New Agent, as successor Administrative Agent, in each case which shall be in form and substance reasonably satisfactory to the Resigning Agent and the New Agent; and

(ii) using its best efforts to transfer physical possession to the New Agent, as successor Agent, of any physical Collateral previously received by the Resigning Agent.

(b) The Resigning Agent, as prior Administrative Agent, acknowledges and agrees that from and after the Effective Date the New Agent, as successor Administrative Agent, is authorized to file on behalf the Resigning Agent, as prior Administrative Agent, amendments to the existing UCC and PPSA financing statements filed with respect to the Loan Documents, including, without limitation, those listed on Schedule 1, as may be necessary to reflect the New

Agent, as successor Administrative Agent, as the secured party, each in form and substance satisfactory to the New Agent, as successor Administrative Agent.

(c) Schedule 2 sets forth all possessory Collateral delivered to the Resigning Agent. On the Effective Date, the Resigning Agent shall deliver to the New Agent, and the New Agent shall take physical possession of, any and all such possessory Collateral and the accompanying powers or endorsements. Schedule 2 sets forth each deposit account control agreement, mortgage, intellectual property security agreement and insurance certificate delivered to the Resigning Agent prior to the Effective Date, in each case related to the Liens on the Collateral. The New Agent agrees that it shall, as promptly as practicable following the Effective Date, effect the substitution of the New Agent in any actions contemplated by this Section 6.

(d) Each party to this Agreement hereby agrees from time to time, upon request of any other party, to take such additional actions and to execute and deliver such additional documents and instruments as such other party may reasonably request to effect the transactions contemplated by, and to carry out the intent of, this Agreement.

Section 7. Amendments to Credit Agreement. From and after the Effective Date, (a) all references to the Administrative Agent in the Loan Documents shall refer to the New Agent in its capacity as administrative agent under the Loan Documents or any successor administrative agent of the New Agent and (b) all references to the Fee Letter shall refer to the fee letter between the New Agent and the Company, dated as of the Effective Date, as amended, restated, supplemented or otherwise modified from time to time.

Section 8. Notice to Successor Agent. Any notice to be given to the New Agent, as successor Agent, under this Agreement shall be delivered to the New Agent at the address, facsimile number, electronic mail address or telephone number specified for the Resigning Agent on Schedule 10.02(a) of the Credit Agreement or to such other address, facsimile number, electronic mail address or telephone number as the New Agent may designate by written notice to the other parties to the Credit Agreement given in a manner designated in Section 10.02 of the Credit Agreement.

Section 9. No Waiver. No delay or failure on the part of any party hereto in exercising any right, power or remedy under this Agreement shall effect or operate as a waiver thereof, nor shall any single or partial exercise thereof or any abandonment or discontinuance of steps to enforce such right, power or remedy preclude any further exercise thereof or of any other right, power or remedy.

Section 10. No Oral Modification. This Agreement may not be amended except upon the written agreement of all of the parties hereto; provided that the foregoing shall not limit or modify the provisions set forth in Section 10.01 of the Credit Agreement relating to amendments, waivers and modifications of the Loan Documents.

Section 11. Binding Upon Successors and Assigns. This Agreement shall inure to the benefit of, and shall be binding upon, the parties hereto and their respective successors and permitted assigns under the Credit Agreement.

Section 12. Governing Law. THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.

Section 13. Partial Invalidity; Severability. If any of the provisions of this Agreement, or the application thereof to any person, party or circumstances, shall, to any extent, be invalid or unenforceable, the remainder of this Agreement, or the application of such provision or provisions to persons, parties or circumstances other than those as to whom or which it is held invalid or unenforceable, shall not be affected thereby, and every provision of this Agreement shall be valid and enforceable to the fullest extent permitted by law.

Section 14. Execution in Counterparts. This Agreement may be executed in any number of counterparts and by different parties hereto in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page of this Agreement by facsimile or electronic transmission of a PDF file shall be effective delivery of a manually executed counterpart of this Agreement.

Section 15. Jurisdiction. Paragraph (b) of Section 10.16 of the Credit Agreement is hereby incorporated herein by reference, mutatis mutandis.

Section 16. Waiver of Jury Trial. THE PARTIES TO THIS AGREEMENT EACH WAIVES ANY RIGHT TO A TRIAL BY JURY IN ANY ACTION OR PROCEEDING TO ENFORCE OR DEFEND ANY RIGHTS UNDER THIS AGREEMENT AND THE OTHER LOAN DOCUMENTS OR RELATING THERETO OR ARISING FROM THE LENDING RELATIONSHIP WHICH IS THE SUBJECT OF THE CREDIT AGREEMENT AND AGREES THAT ANY SUCH ACTION OR PROCEEDING SHALL BE TRIED BEFORE A COURT AND NOT BEFORE A JURY.






