**FIRST AMENDMENT TO
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **FIRST AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT** (“**Amendment**”) is entered into as of September 24, 2019, by and among EAST WEST BANK (“**Bank**”) and STUDIO 71, LP, a Delaware limited partnership (“**Grantor**”).

RECITALS

A. On November 17, 2017, Bank and Grantors entered into that certain Intellectual Property Security Agreement (the “**Agreement**”), pursuant to which Grantor granted to Bank a security interest in certain Copyrights, Trademarks and Patents to secure the obligations of each Grantor in connection with that certain Loan and Security Agreement by and between Bank and Grantor (as the same may be amended, modified or supplemented from time to time, the “**Loan Agreement**”; capitalized terms used herein are used as defined in the Loan Agreement).

B. Bank and Grantor desire to amend Exhibit A to the Agreement to add certain additional Trademarks not previously included on such Exhibit A.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound, as collateral security for the prompt and complete payment when due of its obligations under the Loan Agreement and any other Loan Document now existing or hereafter arising between Grantor and Bank, each Grantor hereby represents, warrants, covenants and agrees as follows:

AGREEMENT

Exhibit A to the Agreement is hereby deleted in its entirety and replaced with Exhibit A attached hereto.

Except as set forth in this Amendment, all terms and provisions of the Agreement are hereby ratified and confirmed and shall be and remain unmodified and in full force. This Amendment supersedes any other purported modification of the Agreement, whether or not executed by the parties or any of them.

This Agreement may be executed in two or more counterparts, each of which shall be deemed an original but all of which together shall constitute the same instrument.


