## RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is made and effective as of September 24<sup>th</sup>, 2019 and granted by STONEGATE ASSET COMPANY II, LLC, a Delaware limited liability company (the "Lender"), in favor of CINCINNATI PRESERVING COMPANY, an Ohio corporation, and their successors, assigns and legal representatives (the "Borrower").

WHEREAS, Borrower has executed and delivered to Lender a Credit dated on or about March 27, 2019 (the "Credit Agreement") and other agreements, documents and instruments contemplated by the transactions contained in the Credit Agreement. The Credit Agreement, together with all agreements, documents and instruments executed and/or delivered to Lender by any person in connection therewith, as the same may be amended, restated, extended, replaced or otherwise modified from time to time, shall be referred to collectively as the "Loan Documents". Pursuant to the terms of the Credit Agreement, Borrower is liable for the payment and performance of the "Obligations" (as such term is defined in the Credit Agreement) as further described therein. Pursuant to the terms of the Loan Documents and the Short Form Trademark Security Agreement dated as of March 27, 2019 ("Trademark Security Agreement"), Borrower had granted to Lender a security interest in and to the "Robert Rothschild Trademark Collateral" (defined below) in order to secure repayment of Obligations pursuant to the Credit Agreement. The Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 6604, Frame 0607 on March 29, 2019; and

WHEREAS, on the date hereof, Borrower, as seller, and RRF FOODS INC., an Ohio corporation, as purchaser ("Purchaser"), are entering an Asset Purchase Agreement (the "APA") pursuant to which Borrower has agreed to sell, and Purchaser has agreed to buy certain "Acquired Assets" (as defined in the APA) on the terms and conditions set forth therein. The Acquired Assets include, among other items, the Robert Rothschild Trademark Collateral;

WHEREAS, the Borrower has requested that the Lender enter into this Release in order to effectuate, evidence and record the release and reassignment to the Borrower of any and all right, title and interest the Lender may have in the Robert Rothschild Trademark Collateral pursuant to the Loan Documents and the Trademark Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby states as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Trademark Security Agreement, as applicable

2. Release of Security Interest. Lender hereby terminates the Trademark Security Agreement solely with respect to the Robert Rothschild Trademark Collateral (as defined below) and terminates, releases and discharges any and all security interests that it has pursuant to the Loan Documents in any and all right, title and interest of the Borrower, and reassigns to the Borrower any and all right, title and interest that it may have, in, to and under the following (collectively, the "Trademark Collateral"):

- (a) the trademarks listed on Schedule 1 hereto;

- (b) all extensions, renewals and reexaminations of the foregoing;
- (c) all goodwill of the business connected with the use of, and symbolized by, the foregoing; and
- (d) all income, royalties, and proceeds at any time due or payable or asserted under; and
- (e) with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

3. Further Assurances. Lender hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Release upon request by Borrower or Purchaser. Following the date hereof, Lender agrees, at the Borrower's or Purchaser's expense, to take all further actions, and provide to the Grantors and their successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Borrower or Purchaser and their successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

4. Governing Law. This Release and any claim, controversy, dispute, or cause of action (whether in contract or tort or otherwise) based upon, arising out of, or relating to this Release and the transactions contemplated hereby and thereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Ohio, without giving effect to any choice or conflict of law provision or rule that would prevent the application of this Section (whether of the State of Ohio or any other jurisdiction).


