RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

This RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS ("Release"), effective as of July 31, 2019, given by **MORGAN STANLEY SENIOR FUNDING, INC.**, as Collateral Agent ("Agent") to **MICRON TECHNOLOGY, INC.**, a Delaware corporation, ("Grantor"), as follows:

W I T N E S S E T H

WHEREAS, pursuant to that certain Credit Agreement dated as of April 26, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), the Lenders (as defined in the Credit Agreement) have agreed to extend credit to the Borrower (as defined in the Credit Agreement);

WHEREAS, in connection with the Credit Agreement, the Grantor executed that certain Guarantee and Collateral Agreement, dated as of April 26, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Collateral Agreement") and granted to the Agent a security interest in the United States trademark registration and applications set forth on Schedule A attached hereto (the "Trademarks") to secure the Obligations (as defined in the Collateral Agreement);

WHEREAS, in furtherance of the Collateral Agreement, the Grantor executed a Supplement No. 3 to Trademark Security Agreement dated January 24, 2017 (the "Trademark Security Agreement"), which was recorded by the U.S. Patent and Trademark Office on February 10, 2017, at Reel / Frame no. 5986 / 0626;


WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Trademarks to the Grantor and to terminate the encumbrance created by the Trademark Security Agreement and the Collateral Agreement in respect of the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby terminates, releases, cancels, relinquishes and discharges the security interest in the Trademarks created by the Trademark Security Agreement and the Collateral Agreement and reassigns all right, title and interest it has in the Trademarks to the Grantor.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE GRANTOR'S AND THE COLLATERAL AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
