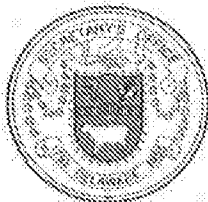



## Certificate of Ownership and Merger
