RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Grantor has requested that Agent release its security interests in the Trademarks listed on Schedule I hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby fully discharges, releases and terminates its security interests in and liens on the Trademarks listed on Schedule I hereto and any right, title or interest of the Agent in the foregoing under the Security Documents shall hereby cease and become void.
