## **RELEASE OF GRANT OF SECURITY INTEREST IN PATENTS AND TRADEMARKS**

THIS RELEASE OF GRANT OF SECURITY INTEREST IN PATENTS AND TRADEMARKS ("Release"), dated as of September 24, 2019, is made by Enhanced Small Business Investment Company, LP, a Delaware limited partnership, as Lender ("Lender") in favor of Café Valley, Inc., an Arizona corporation ("Pledgor"), and is as follows:

WHEREAS, pursuant to the Grant, Pledgor granted to Lender a security interest in (a) all of its right, title and interest in and to certain (i) trademark applications and registrations listed on Schedule A attached hereto (all such trademarks, registrations, and applications, collectively, the "Trademarks") and (ii) patents and patent applications listed on Schedule A attached hereto (all such patents, registrations and applications, collectively, the "Patents") and (b) the use thereof, together with all proceeds and products thereof and the goodwill of the business symbolized by the Trademarks (collectively with clause (a), the "IP Collateral"); and

WHEREAS, Lender desires to release its rights and security interests in the IP Collateral.



