**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARK RIGHTS**

This TERMINATION AND RELEASE (“Release”) dated as of September 25, 2019 from JPMORGAN CHASE BANK, N.A., a national banking association, in its capacity as Administrative Agent (the “Administrative Agent”) for the Lenders party to the Credit Agreement, dated as of June 27, 2018 (as amended on August 27, 2018 by that certain First Amendment to Credit Agreement, as further amended on June 17, 2019 by that certain Second Amendment to Credit Agreement, and as the same may be further amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), to BARTECA RESTAURANTS, LLC, a Delaware limited liability company, located at 22 Elizabeth Street, Norwalk, CT 06854 (“Barteca”) and CENTER CUT HOSPITALITY, INC., a Delaware corporation, located at 2900 Ranch Trail, Irving, TX 75063 (“Center Cut”) (Barteca and Center Cut, each a “Grantor” and collectively “Grantors”).

WITNESSETH:

WHEREAS, pursuant to that certain Security Agreement, dated as of June 27, 2018, made by DEL FRISCO’S RESTAURANT GROUP, INC., a Delaware Corporation (the “Borrower”) and certain subsidiaries of the Borrower (including Grantors, each a Wholly-Owned Subsidiary of the Borrower) in favor of the Administrative Agent (the “Security Agreement”), Borrower and Grantors granted a security interest (the “Security Interest”) to the Administrative Agent in certain collateral, including the Trademarks;

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of June 27, 2018, among the Administrative Agent, Borrower and Grantors (the “Trademark Security Agreement”), Grantors, by reference to the Security Agreement, reaffirmed their intent to grant and granted a Security Interest to the Administrative Agent specifically in the Trademark Collateral (as that term is defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the U.S. Patent and Trademark Office (“USPTO”) on September 7, 2018 at Reel 6432 and Frame 0897;

WHEREAS, pursuant to that Partial Termination and Release dated as of September 21, 2018 among the Administrative Agent and Center Cut (the “Partial Release”), the Administrative Agent terminated and released certain specified collateral, namely the Released Collateral (as defined in the Partial Release);

WHEREAS, the Partial Release was recorded in the Trademark Division of the USPTO on October 1, 2018 at Reel 6485 and Frame 0798;

WHEREAS, at the request of the Borrower, the Administrative Agent has agreed to evidence and confirm the termination and release of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent hereby states as follows:

1. Definitions. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreement, the Security Agreement or the Credit Agreement, as applicable.

2. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges, without recourse, representation or warranty, its Security Interest in the Trademark Collateral, including the U.S. trademark registrations and applications listed on Schedule A hereto, and any right, title or interest of the Administrative Agent therein shall hereby cease and become void.

3. Purpose. This Release has been executed and delivered by the Administrative Agent for the purpose of recording the release of the Security Interest with the USPTO.


4. Further Assurances. The Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.

5. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
