**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of September 25, 2019 (“Release”), is made by Bank of America, N.A., as Agent (“Administrative Agent”) in favor of STEMCO Products, Inc. (successor-by-merger to STEMCO LP), a Delaware corporation (“Debtor”).

WHEREAS, pursuant to that certain Amended, Restated and Consolidated Trademark Security Agreement dated as of April 26, 2016 (as amended, modified, restated or supplemented, the “Trademark Security Agreement”), and Amendment to Amended, Restated and Consolidated Trademark Security Agreement dated as of February 26, 2010 (“Amendment”), each by and among the Debtor, Agent, and others party thereto, Debtor granted to the Agent, for the benefit of itself and the other Secured Parties, a continuing security interest in and lien upon all of Debtor’s right, title and interest in, to and under the Additional Trademark Collateral;

WHEREAS, the Amendment was recorded at the United States Patent and Trademark Office (“USPTO”) on March 8, 2010 at Reel 4162 Frame 0796 (“Notice”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent, on behalf of itself and the Secured Parties, and Debtor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement or Amendment.

SECTION 2. Termination and Release. Agent, on behalf of itself and the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in and lien upon all of Debtor’s right, title and interest in, to and under solely the Additional Trademark Collateral listed on Schedule A attached hereto, granted pursuant to the Trademark Security Agreement or Amendment; and

(b) authorizes the recordation of this Release with the USPTO at Debtor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of North Carolina.

IN WITNESS WHEREOF, the Administrative Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
