RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of September 26, 2019 (this "Release"), is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, in its capacity as administrative agent (in such capacity, the "Agent"), in favor of ATLANTA RADIO, LLC, DETROIT RADIO, LLC, and WBAP-KSCS ASSETS, LLC ("Obligors"). Capitalized terms used but not otherwise defined herein shall have the meaning set forth in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, the Obligors and the Agent entered into that certain Grant of Security Interest in United States Trademark Rights, dated as of June 4, 2018 (the "Security Agreement"), pursuant to which the Obligors granted to the Agent a security interest in and to all of their right, title and interest in, to and under the Collateral owned by the Obligors including, without limitation, the trademark registrations and applications listed on Schedule A attached hereto;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on August 20, 2018 at Reel 6437 and Frame 0270; and

WHEREAS, the Obligors have requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in and to the Collateral.


