TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (the “Assignment”) dated as of September 22, 2019 (the “Effective Date”), is made by and among IHS Global Limited, a private company incorporated and registered in England and Wales with number 00788737 (the “Assignor”) and Jane’s Group UK Limited, a private company incorporated and registered in England and Wales with number 12199785 (the “Assignee”).

WITNESSETH:

WHEREAS Assignor has agreed to transfer, convey and assign, among other things, all of Assignor’s right, title and interest in and to the trademark registrations as set forth on Schedule A attached hereto (the “Trademarks”), together with all goodwill associated therewith; and

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and subject to the terms and conditions therein, the parties agree as follows:

1. Assignment. Assignor hereby transfers, conveys and assigns to Assignee, its successors and assigns, and Assignee hereby accepts from Assignor, all of Assignor’s respective right, title and interest in and to the Trademarks, together with all goodwill associated with, attaching to and represented by the Trademarks, and the right to sue or recover and retain damages, other financial remedies and costs and attorneys’ fees for past, present and future infringement, unauthorised use, dilution, passing off and misappropriation of, and all other causes of action arising from ownership of, the Trademarks and to fully and entirely stand in the place of Assignor in all matters related to the Trademarks.

2. Cooperation. This Assignment has been executed and delivered by the Assignor, inter alia, for the purpose of recording the assignment herein with the appropriate government entity. At Assignee’s reasonable cost and expense, Assignor shall execute and deliver such other documents and take all such other reasonable actions which Assignee, its successors and/or assigns may reasonably request to effect the terms of this Assignment, including its recordation in relevant state and national trademark offices.

3. Warranties. THIS AGREEMENT CONTAINS NO EXPRESS OR IMPLIED WARRANTIES OF NONINFRINGEMENT OF THIRD PARTY INTELLECTUAL PROPERTY RIGHTS, OR REGARDING THE SCOPE, VALIDITY, OR ENFORCEABILITY OF ANY TRANSFERRED INTELLECTUAL PROPERTY RIGHTS.

4. General Provisions. This Assignment, including Schedule A hereto, constitutes the entire understanding and agreement of the parties hereto with respect to the subject matter hereof and supersede all prior and contemporaneous

agreements or understandings, inducements or conditions, express or implied, written or oral, between and among the parties with respect hereto. This Assignment may not be supplemented, altered, or modified in any manner except by a writing signed by all parties hereto. The failure of any party to enforce any terms or provisions of this Assignment shall not waive any of its rights under such terms or provisions.

5. Successors and Assigns. This Assignment shall bind and inure to the benefit of the respective parties and their assigns, transferees and successors.

6. Governing Law; Jurisdiction and Venue. This Assignment shall be governed by, and construed in accordance with, the law of England and Wales, without regard to any conflict of laws provisions thereof that would result in the application of the laws of another jurisdiction. Assignee and Assignor hereby consent to and submit to the exclusive jurisdiction and venue of the courts located in England and Wales for enforcement or interpretation of this Assignment, and for any dispute or claim that arises out of or in connection with this Assignment or its subject matter or formation (including non-contractual disputes or claims).




