**UNITED STATES TRADEMARK SECURITY AGREEMENT**

This TRADEMARK SECURITY AGREEMENT (this “**Agreement**”) dated as of September 27, 2019 is made by and between CADENCE BANK, N.A., a national banking association (together with its successors and assigns, the “**Lender**”), and THOMAS REPROGRAPHICS, INC., a Texas corporation (together with its successors and permitted assigns, the “**Grantor**”).

WHEREAS, this Agreement will be filed with the United States Patent and Trademark Office to among other things indicate that Lender is collateral assignee with respect to the Trademarks (as defined herein) listed on Schedule A hereto;

WHEREAS, the Grantor is the owner of certain trademarks, including the applications and registrations thereof, together with the goodwill of the business connected with the use of and symbolized by the trademarks and all proceeds thereof, including, without limitation, any and all past, present and future causes of action which may exist by reason of infringement thereof, set forth on Schedule A hereto (collectively, the “**Trademarks**”);

WHEREAS, Grantor, the Lender and the other parties thereto executed a Credit Agreement, dated as of September 27, 2019 (as amended, restated, amended and restated, modified or supplemented from time to time, the “**Credit Agreement**”), pursuant to which the Lender has agreed to make certain loans and other extensions of credit to the Borrower; and

WHEREAS, the Grantor, the Lender, and the other parties thereto executed a Security Agreement, dated as of September 27, 2019 (as amended, restated, amended and restated, modified or supplemented from time to time, the “**Security Agreement**”), pursuant to which the Grantor granted and agreed to grant to Lender a security interest in certain of its assets to secure the Borrower’s obligations to Lender under the Credit Agreement.


