**TERMINATION AND RELEASE OF SECURITY  
INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "*Termination and Release*") is granted as of September 30, 2019 by **Patriarch Partners Agency Services, LLC**, a Delaware limited liability company ("*PPAS*"), in favor of **LVD Acquisition, LLC**, a Delaware limited liability company (the "*Pledgor*").

**WHEREAS**, PPAS and Zohar Waterworks, LLC, a Delaware limited liability company ("*Waterworks*") entered into the certain Trademark Collateral Security Agreement, dated as of August 26, 2005 (the "*Trademark Agreement*"), pursuant to which PPAS was granted a security interest in and lien on the Marks (as defined in the Trademark Agreement), and in connection with such Trademark Agreement a security interest in the Marks was recorded with the United States Patent and Trademark Office ("*USPTO*") on August 26, 2005, at Reel 003224, Frame 0777;

**WHEREAS**, in connection with a sale pursuant to Section 363 of Title 11 of the United States Code, Pledgor and Waterworks entered into that certain Asset Purchase Agreement, dated as of April 2, 2009, as amended from time to time, pursuant to which Pledger acquired certain assets of Waterworks including the Marks;

**WHEREAS**, pursuant to that certain Security Agreement, dated as of June 1, 2009, (as amended, restated, supplemented or otherwise modified from time to time, the "*Security Agreement*"), among the Pledgor, B2 Acquisition, Inc., a Delaware corporation and PPAS, the Pledgor executed and delivered to PPAS an Intellectual Property Security Agreement (Patents & Trademarks) dated as of June 1, 2009 (the "*IP Security Agreement*"), granting PPAS a security interest in and lien on the Collateral (as defined in the IP Security Agreement) and a security interest in the Collateral was recorded with the United States Patent and Trademark Office ("*USPTO*") on April 15, 2010;

**WHEREAS**, Ankura Trust Company, LLC is the successor agent to PPAS and contemporaneously with the delivery of this Termination and Release, is delivering a Termination and Release of Security Interest in Intellectual Property with respect to the Collateral;

**WHEREAS**, to the extent that the Collateral (and the termination and releases with respect thereto) does not encompass all or any portion of the Marks, the Pledgor, as successor in interest to Waterworks, has requested that PPAS terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Pledgor in, to and under all of the Marks, including the trademarks as fully described on the attached Schedule I as herein provided; and

**WHEREAS**, the Pledgor has requested that PPAS provide a document suitable for recording in the USPTO to evidence the release of its security interests in and liens on the Marks as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, PPAS hereby agrees as follows:

1. **Release of Security Interest.** PPAS hereby terminates the Trademark Agreement and releases, terminates and discharges all liens and security interests created thereunder, and releases and relinquishes to the Pledgor all of PPAS's right, title and interest in, to and under the Marks, including the trademarks set forth in Schedule I, and all goodwill associated therewith.

2. **Recordation.** PPAS authorizes and requests that this Termination and Release be recorded at the USPTO and any other applicable government office.

3. **Further Assurances.** PPAS agrees to take all further actions, and provide to the Pledgor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, in each case, at the Pledgor's expense, as the Pledgor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Termination and Release.



## TRADEMARK COLLATERAL SECURITY AGREEMENT

**THIS TRADEMARK COLLATERAL SECURITY AGREEMENT** (this "Assignment"), is made by and between ZOHAR WATERWORKS, LLC, a Delaware limited liability company (the "Grantor"), and PATRIARCH PARTNERS AGENCY SERVICES, LLC, a Delaware limited liability company, as agent (in such capacity, the "Agent") for itself and the Lenders referenced below.

**WHEREAS**, Grantor has adopted, used and is using, and is the sole owner of the marks set forth on Schedule 1 hereof (collectively, the "Marks");

**WHEREAS**, under the terms of, and as a condition precedent to the effectiveness of, that certain Credit Agreement, dated as of August 26, 2005 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Zohar Waterworks, LLC, as borrower thereunder, the subsidiaries of the Borrower from time to time guarantors thereto, and the financial institutions from time to time lenders thereunder (collectively, the "Lenders"), and Agent, the Grantor entered into the Security Agreement, dated as of even date therewith (the "Security Agreement");

**WHEREAS**, to secure the due and prompt payment and performance of the Obligations (as defined in the Security Agreement), Grantor pledged, assigned, hypothecated and transferred, and granted to the Agent, for itself and for the benefit of the Lenders, a continuing security interest in all of the Grantor's right, title and interest in certain collateral, including the Marks; and

**WHEREAS**, it is the purpose of this document to memorialize the aforementioned security interest in a form suitable for recordation in the United States Patent and Trademark Office;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, effective as of the date of the Credit Agreement set forth above, to secure the due and prompt payment and performance of the Obligations, Grantor hereby pledges, assigns, hypothecates and transfers, and grants to the Agent, for itself and for the

benefit of the Lenders, a continuing security interest and lien in and to the Marks and all registrations and applications for registrations of the Marks, including the registrations and applications identified on Schedule 1, together with the goodwill of the business symbolized by the Marks and together with all of Grantor's right to sue and recover for infringement of the Marks, free and clear of all liens, claims, charges, security interests, and other interests or encumbrances.
