**RELEASE OF CONFIRMATORY GRANT
OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF CONFIRMATORY GRANT OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made effective as of October 1, 2019, by U.S. BANK NATIONAL ASSOCIATION, a national banking association (the "Secured Party") for itself and as administrative agent for the Lenders (as defined in the Credit Agreement referenced below) in favor of DAYSMART SOFTWARE, LLC, a Delaware limited liability company (successor in interest to DaySmart Blocker, Inc.) (the "Grantor").

WHEREAS, the Grantor, the Secured Party, and the Lenders are parties to that certain Credit Agreement dated as of September 16, 2016 (as amended, supplemented, extended, restated, or otherwise modified from time to time, the "Credit Agreement") pursuant to which the Lenders agreed, among other things, to extend to the Grantor certain credit accommodations;

WHEREAS, the Grantor granted security interests to the Secured Party under the Pledge and Security Agreement and Irrevocable Proxy dated as of September 16, 2016 (as amended, restated, supplemented, or otherwise modified from time to time, the "Security Agreement");

WHEREAS, the Grantor owns the trademarks listed on Exhibit A, which are registered with the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered a Confirmatory Grant of Security Interest in Trademarks dated as of September 16, 2016 (the "First Confirmatory Grant") granting the Secured Party, among other collateral as set forth therein, a security interest in and lien on certain of the Trademarks;

WHEREAS, the First Confirmatory Grant was recorded with the United States Patent and Trademark Office ("USPTO") against certain of the Trademarks on September 16, 2016, at Reel 5878, Frame 0369;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered a Confirmatory Grant of Security Interest in Trademarks dated as of October 22, 2018 (the "Second Confirmatory Grant") granting the Secured Party, among other collateral as set forth therein, a security interest in and lien on certain of the Trademarks;

WHEREAS, the Second Confirmatory Grant was recorded with the USPTO against certain of the Trademarks on October 22, 2018, at Reel 6463, Frame 0034;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered a Confirmatory Grant of Security Interest in Trademarks dated as of December 28, 2018 (the "Third Confirmatory Grant") granting the Secured Party, among other collateral as set forth therein, a security interest in and lien on certain of the Trademarks;

WHEREAS, the Third Confirmatory Grant was recorded with the USPTO against certain of the Trademarks on January 8, 2019, at Reel 6519, Frame 0595; and

WHEREAS, with respect to the Trademarks, the Grantor has satisfied all of its obligations to the Secured Party and has requested that the Secured Party terminate and release all of its security interests in and liens on the Trademarks.

WHEREAS, pursuant to the Credit Agreement and the other Loan Documents, the Secured Party's security interests in and liens on the Trademarks listed on Exhibit A hereto are automatically released upon satisfaction in full of the Grantor's obligations under the Credit Agreement.


NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby agrees that:

1. Termination and Release of Security Interest. The Secured Party hereby terminates, releases, and discharges all of its security interest in and liens on the Trademarks listed on Exhibit A hereto, and the Secured Party hereby reassigns and transfers to the Grantor, without representation, warranty or recourse, all of the Secured Party's right, title and interest in and to the Trademarks, effective as of the date set forth above. The Secured Party acknowledges that this Release may be filed along with any other necessary documentation with the USPTO or any other applicable governmental office to evidence the release granted herein at the sole expense of the Grantor. The Secured Party authorized the Grantor (or its authorized representatives, including its legal counsel) to record this Release with the USPTO and other applicable registry at the sole expense of the Grantor and agrees to provide the Grantor with any information and additional authorization necessary (including, but not limited to, the execution, acknowledgment, procurement and delivery of any further documents and other acts as may reasonably be requested by the Grantor) to fully effectuate the release of the security interest in the Trademarks.


