ASSIGNMENT

WHEREAS:-



- A. The Assignor is the registered owner of the trade marks set out in the Schedule to this Assignment (the "Trade Marks").

 - (a) all goodwill attaching to the Trade Marks and in respect of the business relating to the goods and/or services for which the Trade Marks are registered or used; and
 - (b) the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of the Trade Marks whether occurring before, on, or after the date of this Assignment.
2. The assignment shall take effect on the date of this Assignment.
3. The Assignor hereby undertakes to do all such things and to execute all such documents as may be required by the Assignee to record or register the rights assigned in this Assignment with the relevant Trade Marks Office or Registry for the Trade Marks.


