Pursuant to Title 8, Section 252 of the General Corporation Law of the State of Delaware (the “DGCL”), Verint Americas Inc., a Delaware Corporation (the “Surviving Corporation”), in connection with the merger of Kiran Analytics, Inc., a California corporation (the “Company”), with and into the Surviving Corporation (the “Merger”), hereby certifies as follows:

**FIRST:** The names and states of incorporation of each of the constituent corporations to the Merger are as follows:

**FIFTH:** The Merger shall become effective at such time as this Certificate of Merger is duly filed and accepted by the Secretary of State of the State of Delaware.

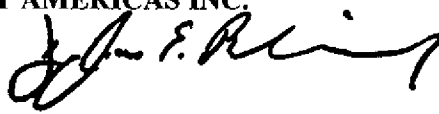
