**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of October 1, 2019, by **JEFFERIES FINANCE LLC**, as Collateral Agent (in such capacity, together with its successors and assigns in such capacity, “Collateral Agent”) in favor of **SERVPRO INTELLECTUAL PROPERTY, LLC**, a Tennessee limited liability company with an address at 801 Industrial Boulevard Gallatin, TN 37066 (the “Grantor”).

W I T N E S S E T H:

WHEREAS, pursuant to that Second Lien Security Agreement, dated as of March 26, 2019, made by Grantor and the other parties thereto in favor of the Collateral Agent (the “Security Agreement”), a security interest (the “Security Interest”) was granted by Grantor to the Collateral Agent in certain collateral, including the Trademarks (as defined in the Security Agreement).

WHEREAS, by reference to the Security Agreement, the Grantor entered into a certain trademark security agreement dated March 26, 2019 (the “Trademark Security Agreement”) with Collateral Agent, which was recorded on March 26, 2019 at the United States Patent and Trademark Office at Reel 6601, Frame 0030.

WHEREAS, Grantor granted Collateral Agent, under the terms of the Trademark Security Agreement by reference to the Security Agreement, and reaffirmed its intent to grant, a Security Interest in favor of Collateral Agent, in, to and under all of its Trademark Collateral, including without limitation the Trademarks listed in Schedule A.

WHEREAS, Collateral Agent has agreed to terminate and release its Security Interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby agrees as follows:

1. Definitions. Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
2. Release. Collateral Agent hereby releases, terminates and discharges the Trademark Security Agreement, the Security Interest and any and all of its interest in the Trademark Collateral (including without limitation the trademark registrations listed in Schedule A), including all of the goodwill connected with the use of, and symbolized thereby, and assigns, transfers and conveys to Grantor the Security Interest in such Trademark Collateral.
