**RESOLVED**, that Article I of the Articles of Incorporation of this Corporation shall be amended to read as follows:

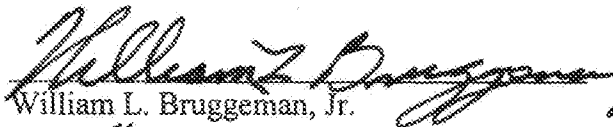



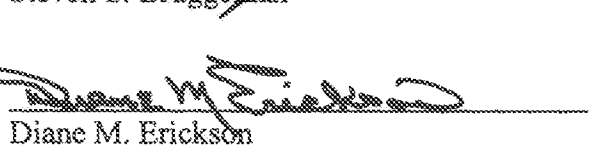
Article I
