**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (the "Release") is dated as of October 1, 2019 by BNP PARIBAS, in its capacity as agent for the Lender Group (in such capacity, together with its successors and assigns in such capacity, the "Agent") in favor of WILLIAMS EQUIPMENT AND SUPPLY COMPANY, a Tennessee corporation and WILLIAMS EQUIPMENT AND SUPPLY COMPANY OF LOUISIANA, a Louisiana corporation (each, a "Grantor" and collectively, the "Grantors"). All capitalized terms used but not otherwise defined herein have the meanings assigned to them in the Guaranty and Security Agreement (as defined below).

WITNESSETH

WHEREAS, the Grantors and the Agent entered into that certain Guaranty and Security Agreement, dated as of June 30, 2017 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Guaranty and Security Agreement");

WHEREAS, pursuant to the Guaranty and Security Agreement, the Grantors executed and delivered to the Agent that certain Trademark Security Agreement dated as of May 29, 2018 (the "Trademark Security Agreement") and recorded with the United States Patent and Trademark Office on May 29, 2018 at Reel/Frame Nos. 6391/0899 and 6391/0915, pursuant to which the Grantors unconditionally granted, assigned, and pledged to Agent, for the benefit of each member of the Lender Group, to secure the Secured Obligations, a continuing security interest in all of the Trademark Collateral (as defined in the Trademark Security Agreement); and


WHEREAS, the Grantors have requested that the Agent release its security interest in the Trademark Collateral.


NOW, THEREFORE, in consideration of the foregoing, the Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title or interest in or to any and all of the Trademark Collateral, including the trademark registration and application set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Agent may have obtained in, to and under the Trademark Collateral under the Guaranty and Security Agreement and the Trademark Security Agreement.
