NOTICE OF RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS

This NOTICE OF RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS (as amended, restated, supplemented or otherwise modified, this “Notice of Release”), effective as of October 1, 2019, is made by WELLS FARGO BANK, NATIONAL ASSOCIATION (successor by merger to Wachovia Bank, National Association), as Administrative Agent (the “Administrative Agent”).

The invalidity or unenforceability of any provision of this Notice of Release shall not affect the validity or enforceability of any other provision of this Notice of Release, which shall remain in full force and effect.

This Notice of Release and all of the provisions hereof shall be binding on and inure to the benefit of the parties hereto and their respective successors and assigns.
