WHEREAS, the Agent wishes to provide a document suitable for recording in the United States Patent and Trademark Office the release, relinquishment and discharge of its liens on and security interest in the Trademarks;

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, Agent hereby terminates, cancels, reassigns, relinquishes, releases and discharges all liens and security interests it has in the Trademarks.


