Pursuant to Section 60.472(2) of Chapter 60 of the Oregon Revised Statutes and Section 10.102 of the Texas Business Organizations Code (the "TBOC"), Pivot, Inc. (the "Corporation"), hereby adopts these Articles of Conversion (the "Articles"), effective as of June 25, 2015, for the purpose of converting the Corporation from an Oregon corporation into a Texas corporation (the "Conversion"). For purposes of compliance with the TBOC, these Articles shall be deemed to be the Corporation's Certificate of Formation (as that term is used and defined in the TBOC).

ARTICLE I

Converting Entity Information;
Entity Information Prior to Conversion

1. The name of the converting entity prior to conversion is Pivot, Inc.
2. The jurisdiction of formation of the converting entity prior to conversion is the State of Oregon.
3. The type of the converting entity prior to conversion is a corporation.
4. The date of formation of the converting entity prior to conversion is February 3, 2012.
5. The converting entity has not been issued a file number by the Texas Secretary of State prior to conversion.

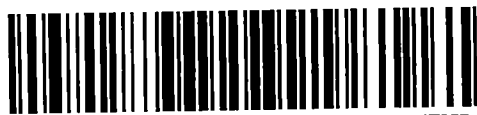
