TRADEMARK RELEASE AND REASSIGNMENT

This Trademark Release and Reassignment is made as of July 26, 2019 by Madison Capital Funding, LLC, as administrative agent ("Grantee").

WITNESSETH

WHEREAS, Grantee and, Product Quest Manufacturing , LLC a Florida limited liability company ("Grantor"), are parties to that certain Trademark Assignment Agreement dated as of September 9, 2015, (the "Agreement"; capitalized terms which are not defined herein have the meaning given to such terms in the Agreement), pursuant to which Grantor granted a security interest to Grantee in the Trademark Collateral (as defined below) as security for certain obligations owing by Grantor and its affiliates to Grantee; and

WHEREAS, the Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on September 16, 2015 at Reel 5624 Frame 0295; and

WHEREAS, Randob Labs Ltd. ("Randob Labs") has purchased certain of Grantor's rights to the trademarks covered by the Agreement pursuant to an Asset Purchase Agreement dated June 12, 2019 (the "APA");

WHEREAS, Randob Labs has requested that Grantee release its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral and reassign the same to Randob Labs; and

WHEREAS, Grantee has agreed to release the entirety of its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases its security interest in and lien on all of Grantor's right, title and interest in the following (collectively, the "Trademark Collateral");

(i) each trademark listed on Schedule A annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(ii) all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of each such Trademark, or (b) injury to the goodwill associated with each such Trademark.

2. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, all of Grantee's right, title and interest (if any) in and to the Trademark Collateral.
