**CONFIRMATION OF RELEASE AND DISCHARGE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

RECITALS:

- A. J.H. McNairn Limited (the "Debtor"), a corporation formed under the laws of the Province of Ontario, is the owner of the trademarks set forth in Exhibit A, the registrations and applications for the trademarks identified therein and the underlying goodwill of the business connected thereto and symbolized thereby (collectively, the "Trademarks").
- B. The Debtor entered into a general security agreement dated May 19, 1983 in favour of Continental Bank of Canada (as amended, modified, supplemented or restated from time to time, the "General Security Agreement") under which the Debtor granted to the Continental Bank of Canada, a security interest in certain property, including the Trademarks, as security for certain obligations.
- C. On or about October 31, 1986, Lloyds Bank Canada acquired substantially all of the assets and property of the Continental Bank of Canada as a going concern.
- D. On or about November 1989, Hongkong Bank of Canada acquired Lloyds Bank Canada.
- E. On or about June 1999, Hongkong Bank of Canada changed its name to HSBC Bank Canada ("HSBC").
- F. All of the obligations secured by the foregoing General Security Agreement have been discharged and paid in full.
- G. HSBC, in its capacity as successor-in title to Continental Bank of Canada, has agreed to issue this document for the purposes of evidencing the foregoing and discharging all security interests registered against the Trademarks.

NOW THEREFORE for good and valuable consideration (the receipt and sufficiency of which are hereby acknowledged), HSBC hereby irrevocably and unconditionally releases and discharges to and in favour of the Debtor and its successors and assigns each and every security interest, lien, mortgage, charge, pledge, assignment and other encumbrance (collectively, "Liens") created under each and every mortgage, charge or security agreement made by the Debtor in favour of HSBC over the Trademarks and HSBC hereby authorizes the Debtor and its solicitors and agents to discharge all registrations of such Liens made against the Trademarks.
