The undersigned has been informed that Newsmax Media, Inc., a Delaware corporation (together with its subsidiaries, the "Company"), intends to prepay to the undersigned all of the liabilities, obligations and indebtedness owing by the Company to the undersigned (the "Indebtedness") with respect to that certain Loan Agreement between the Company and the undersigned, dated May 12, 2016 (as amended or otherwise modified to the date hereof, the "Credit Agreement") and the other loan documents in connection with the Credit Agreement (including but not limited to the "Loan Documents" as defined in the Loan Agreement, the Disclosure and Confession of Judgment dated May 12, 2016, and the Extension Letter Agreement (as defined below)) (collectively, with the Credit Agreement, the "Loan Documents"). 
the Indebtedness shall have been satisfied in full and the liens and security interests of the undersigned in any and all of the property of the Company and any guarantors of the Indebtedness shall be automatically released and terminated, including without limitation, any liens and security interests evidenced by Uniform Commercial Code financing statements and fixture filings (including but not limited to UCC filings with the Secretary of State of Pennsylvania, the Secretary of State of Delaware, the Secretary of State of Florida, and the Secretary of State of New York, and filings with the Office of Tax and Revenue, Recorder of Deeds of Washington, D.C.), real property mortgages and deeds of trust, fleet mortgages and deeds of trust and intellectual property security recordations in the United States Patent and Trademark Office or the United States Copyright Office.

Effective upon the receipt of the Payoff Amount plus the Per Diem Amount, if any, in accordance with the terms of this letter: (i) the Loan Documents will terminate and the Company and any guarantor of the Indebtedness will have no further liability under the Loan Documents, (ii) the undersigned authorizes the Company and its designees to file on behalf of the undersigned (at the Company's sole cost and expense) (a) termination statements of Uniform Commercial Code financing statements and fixture filings, (b) releases of real property or fleet mortgages and deeds of trust (including but not limited to the Office of Tax and Revenue, Recorder of Deeds of Washington D.C.), and (c) releases of intellectual property security recordations in the United States Patent and Trademark Office and the United States Copyright Office, in each case, filed by the undersigned in respect of the Indebtedness, (iii) the undersigned agrees, upon the reasonable request of the Company, the undersigned will execute and deliver to the requesting party additional terminations, releases and satisfactions of the undersigned's liens on, and security

interests in, Company's property and the property of any guarantor of the Indebtedness (at Company's sole cost and expense) as are necessary to evidence the satisfaction of such Company's or such guarantor's obligations to the undersigned under the Loan Documents and the termination of the interests of the undersigned in all collateral held with respect thereto, and (iv) the undersigned shall deliver promptly to, or to arrange for the prompt delivery of, originally executed and notarized (if applicable) copies of canceled promissory notes and releases for each of the other liens granted to the undersigned and any and all pledged collateral in the possession of the undersigned pertaining to the Company or any guarantor of the Indebtedness (including any pledged stock certificates, vessel titles and notes).

INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT (“**IP Security Agreement**”), is made as of this 12th day of May, 2016, by and between **NEWSMAX MEDIA, INC.**, a Delaware Corporation with an address of 750 Park of Commerce Drive, Suite 100, Boca Raton, FL 33487 (the “**Grantor**”), in favor of **R.M.S. FUNDING COMPANY, LLC**, a Delaware limited liability company with an address of 503 Martindale Street, Pittsburgh, PA 15212, or its assigns (the “**Secured Party**”, and together with the Borrower, the “**Parties**”). It is acknowledged and agreed that this IP Security Agreement shall (a) become effective only upon the consummation of the Closing in accordance with the terms of the Loan Agreement (as defined below) and (b) automatically terminate without any action required to be taken by the parties hereto upon the termination of the Loan Agreement in accordance with its terms. Capitalized terms used but not defined herein, shall have the meanings ascribed to such terms in the Loan Agreement.

A. The Grantor and Secured Party have entered into a Loan Agreement dated of even date herewith (the “**Loan Agreement**”).

B. As a condition precedent to the making of the Loan by the Secured Party under the Loan Agreement, Grantor has executed and delivered to the Secured Party that certain Security Agreement dated of even date herewith, made by and among the Grantor and Secured Party (the “**Security Agreement**”).

C. Under the terms of the Security Agreement, at the Closing the Grantor will grant to the Secured Party, a security interest in, among other property, certain intellectual property of the Grantor, and has agreed to execute and deliver this IP Security Agreement, for recording with national, federal and state government authorities, including, but not limited to, the United States Patent and Trademark Office and the United States Copyright Office.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and inconsideration of their mutual covenants and agreements herein contained and intending to be legally bound hereby, covenant and agree as follows:

1. **Grant of Security**. As of the Closing, Grantor hereby pledges and grants to the Secured Party a security interest in and to all of the right, title and interest of such Grantor in, to and under the following (the “**IP Collateral**”):

(a) all patents issued or assigned to, and all patent applications and registrations made by, Grantor including those listed in Schedule 1 hereof (whether issued, established or registered or recorded in the United States or any other country or any political subdivision thereof) and all tangible embodiments of the foregoing, together with any and all (i) rights and privileges arising under applicable law and international treaties and conventions with respect to such Grantor's use of any patents, (ii) inventions and improvements described and claimed therein, (iii) reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof and amendments thereto, (iv) income, fees, royalties, damages, claims and payments now or hereafter due and/or payable thereunder and with respect thereto including damages and payments for past, present or future infringements thereof, (v) rights corresponding

thereto throughout the world and (vi) rights to sue for past, present or future infringements thereof (collectively, the “**Patents**”);

(b) all trademarks (including service marks), slogans, logos, symbols, certification marks, collective marks, trade dress, uniform resource locators (URL's), domain names, corporate names and trade names, whether statutory or common law, whether registered or unregistered and whether established or registered in the United States or any other country or any political subdivision thereof, including those listed in Schedule 2 hereof, that are owned by or assigned to Grantor, all registrations and applications for the foregoing and all tangible embodiments of the foregoing, together with, in each case, the goodwill symbolized thereby and any and all (i) rights and privileges arising under applicable law and international treaties and conventions with respect to Grantor's use of any trademarks, (ii) reissues, continuations, extensions and renewals thereof and amendments thereto, (iii) income, fees, royalties, damages and payments now and hereafter due and/or payable thereunder and with respect thereto, including damages, claims and payments for past, present or future infringements thereof, (iv) rights corresponding thereto throughout the world and (v) rights to sue for past, present and future infringements thereof (collectively, the “**Trademarks**”);

(c) all copyrights (whether statutory or common law, whether established or registered in the United States or any other country or any political subdivision thereof, whether registered or unregistered and whether published or unpublished) including those listed in Schedule 3 hereof, all tangible embodiments of the foregoing and all copyright registrations and applications made by Grantor, in each case, whether now owned or hereafter created or acquired by or assigned to Grantor, together with any and all (i) rights and privileges arising under applicable law and international treaties and conventions with respect to Grantor's use of such copyrights, (ii) reissues, renewals, continuations and extensions thereof and amendments thereto, (iii) income, fees, royalties, damages, claims and payments now or hereafter due and/or payable with respect thereto, including damages and payments for past, present or future infringements thereof, (iv) rights corresponding thereto throughout the world and (v) rights to sue for past, present or future infringements thereof (collectively, the “**Copyrights**”);

(d) all rights of any kind whatsoever of Grantor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(e) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(f) any and all claims and causes of action with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. **Recordation**. Grantor authorizes the Commissioner for Patents, the Commissioner for Trademarks and the Register of Copyrights and any other government

officials to record and register this IP Security Agreement upon request by the Secured Party.

3. **Loan Documents.** This IP Security Agreement has been entered into pursuant to and in conjunction with the Security Agreement, which is hereby incorporated by reference. The provisions of the Security Agreement shall supersede and control over any conflicting or inconsistent provision herein. The rights and remedies of the Secured Party with respect to the IP Collateral are as provided by the Loan Agreement, the Security Agreement and related documents, and nothing in this IP Security Agreement shall be deemed to limit such rights and remedies.

4. **Miscellaneous.**

(a) **Notices.** All notices, requests, consents, claims, demands, waivers and other communications hereunder (each, a “**Notice**”) shall be in writing and addressed to the parties at the addresses set forth on the first page of this IP Security Agreement (or to such other address that may be designated by the receiving party from time to time in accordance with this Section). All Notices shall be delivered by personal delivery, nationally recognized overnight courier (with all fees pre-paid), or certified or registered mail (in each case, return receipt requested, postage pre-paid). Except as otherwise provided in this IP Security Agreement, a Notice is effective only (a) upon receipt by the receiving party, and (b) if the party giving the Notice has complied with the requirements of this Section.

(b) **Governing Law.** This IP Security Agreement and the Loan Documents and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this IP Security Agreement and the Loan Documents and the transactions contemplated hereby and thereby shall be governed by and construed in accordance with the internal Laws of the Commonwealth of Pennsylvania without giving effect to any choice or conflict of Law provision or rule (whether of the Commonwealth of Pennsylvania or any other jurisdiction). The other provisions of Sections GOVERNING LAW, SUBMISSION TO JURISDICTION and VENUE of the Loan Agreement are incorporated herein, *mutatis mutandis*, as if a part hereof.

(c) **Loan Documents.** All of the agreements, conditions, covenants, provisions and stipulations contained in the Loan Documents all of even date herewith are hereby made a part of this IP Security Agreement to the same extent and with the same force and effect as if they were fully set forth herein, and Grantor covenants and agrees to keep and perform them, or cause them to be kept and performed, strictly in accordance with their terms.

(d) **Intentionally Omitted.**

(e) **Counterparts; Integration; Effectiveness.** This IP Security Agreement and any amendments, waivers, consents or supplements hereto may be executed in counterparts, each of which shall constitute an original, but all taken together shall constitute a single contract. This IP Security Agreement and the Loan Documents constitute the entire contract between the Parties with respect to the subject matter hereof and supersede all previous agreements and understandings, oral or written, with respect thereto. Delivery of an executed counterpart of a signature page to this IP Security Agreement by facsimile or in electronic (i.e., “pdf” or “tif”)

format shall be effective as delivery of a manually executed counterpart of this IP Security Agreement.

(f) **Successors and Assigns.** This IP Security Agreement may be assigned, transferred or negotiated by the Secured Party to any Person at any time without notice to or the consent of the Grantor. The Grantor may not assign or transfer this IP Security Agreement or any of its rights hereunder without the prior written consent of the Secured Party. This IP Security Agreement shall inure to the benefit of and be binding upon the parties hereto and their permitted assigns.

(g) **Waiver of Notice.** The Grantor, and all endorsers, sureties and guarantors, if any, hereby jointly and severally waive presentment for payment, demand, notice of demand, notice of nonpayment or dishonor, protest and notice of protest of this IP Security Agreement, and all other notices in connection with the delivery, acceptance, performance, default, or enforcement of the payment of this IP Security Agreement, unless specifically required herein or in the Loan Documents, and agrees that the liability shall be unconditional, without regard to the liability of any other party, and shall not be affected in any manner by any indulgence, extension of time, renewal, waiver or modification granted or consented to by Secured Party. Grantor and all endorsers, sureties, and guarantors, if any, consent to any and all extensions of time, renewals, waivers or modifications that may be granted by Secured Party with respect to the payment or other provisions of this IP Security Agreement, and to the release of the Pledged Collateral or any part thereof, with or without substitution and agree that additional makers, endorsers, guarantors, or sureties may become parties hereto without notice to them or affecting their liability hereunder.

(h) **Amendments and Waivers.** No term of this IP Security Agreement may be waived, modified or amended except by an instrument in writing signed by both of the parties hereto. Any waiver of the terms hereof shall be effective only in the specific instance and for the specific purpose given in said writing.

(i) **Headings.** The headings of the various Sections and subsections herein are for reference only and shall not define, modify, expand or limit any of the terms or provisions hereof.

(j) **No Waiver; Cumulative Remedies.** No failure to exercise and no delay in exercising on the part of the Secured Party, of any right, remedy, power or privilege hereunder shall operate as a waiver thereof; nor shall any single or partial exercise of any right, remedy, power or privilege hereunder preclude any other or further exercise thereof or the exercise of any other right, remedy, power or privilege. The rights, remedies, powers and privileges herein provided are cumulative and not exclusive of any rights, remedies, powers and privileges provided by Law.

(k) **Severability.** If any term or provision of this IP Security Agreement or the Loan Documents is invalid, illegal or unenforceable in any jurisdiction, such invalidity, illegality or unenforceability shall not affect any other term or provision of this IP Security Agreement or the Loan Documents or invalidate or render unenforceable such term or provision in any other jurisdiction.

(l) **Errors, Defects and Imperfections.** Grantor hereby waives and releases all errors, defects and imperfections in any proceedings instituted by Secured Party under the terms of this IP Security Agreement or any of the Loan Documents, as well as all benefit that might accrue to Grantor by virtue of any present or future Laws exempting the Secured Property, or any other property, real or personal, or any part of the proceeds arising from any sale of any such property from attachment, levy, or sale under execution, or providing for any stay of execution, exemption from civil process, or extension of time for payment; and Grantor agrees that any real estate that may be levied upon pursuant to a judgement obtained by virtue hereof, on any writ of execution issued thereon, may be sold upon any such writ in whole or in part in any order desired by Secured Party.

(m) **Construction.** Whenever used, the singular number shall include the plural, the plural the singular, the use of any gender shall be applicable to all genders, the word "Secured Party" shall be deemed to include the successors and assigns of Secured Party, and the word "Grantor" shall be deemed to include Grantor and all endorsers, sureties and guarantors. All obligations, liabilities and duties of Grantor hereunder shall be joint and several so that the aforesaid endorsers, sureties and guarantors of Grantor shall be individually and collectively liable for all such obligations, liabilities and duties.

(n) **Cure Period.** It is acknowledged and agreed that the Secured Party shall not exercise any remedies under the Loan Documents or applicable law with respect to an Event of Default in each case unless and until (a) the Cure Period for such Event of Default has expired and (b) such Event of Default has not been cured during such Cure Period.


