TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

This **TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS** (this "*Termination and Release*") is granted as of October 1, 2019 by **GORDON BROTHERS FINANCE COMPANY**, (the "*Grantee*"), in favor of **OSC SPORTS, INC.**, a Maine corporation (the "*Grantor*").


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in the Grantor's right, title and interest in, to and under the Marks, and all goodwill associated therewith, including those trademarks and trademark applications identified in Schedule A hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.
