RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release"), dated as of September 27, 2019, is executed by **JPMORGAN CHASE BANK, N.A.** (the "Lender"), in favor of **EDEN CREAMERY LLC**, a California limited liability company (the "Grantor"). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Trademark Security Agreement (as defined below).

RECITALS

A. WHEREAS, the Grantor has, pursuant to that certain Trademark Security Agreement dated January 17, 2018, recorded in (i) the United States Patent and Trademark Office (the "USPTO") on January 25, 2018 at Reel 6257, Frame 0582, and (ii) the Canadian Intellectual Property Office ("CIPO") on March 11, 2019 with reference number 1001049936 and file number 1840918 (as the same may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the "Trademark Security Agreement") granted to Lender, on behalf of the Secured Parties, a Security Interest in and to all of Grantor's right, title and interest, including goodwill, in and to the Trademark Collateral, including without limitation those trademarks listed on Exhibit A attached hereto (collectively, the "Released Collateral"); and

B. WHEREAS, Lender wishes to terminate and release, without representation or warranty, its Security Interest in and to the Released Collateral as provided in this release.


C. NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Lender hereby terminates and releases, without recourse, representation or warranty, its Security Interest in and to the Released Collateral and terminates the Trademark Security Agreement. Lender acknowledges that this Release may be filed along with any other necessary documentation with the USPTO, CIPO or any other governmental office to evidence the release granted herein at the sole expense of the Grantor. The Lender authorizes the Grantor to record this Release with the USPTO, CIPO and other applicable registry at the sole expense of the Grantor and agrees to provide the Grantor with any information and additional authorization necessary to effect the release of the Security Interest in the Released Collateral.
