**FIFTH:** A copy of the Plan of Conversion will be furnished by the Converting Entity, prior to the conversion, or the Converted Entity, from and after the conversion, on written request and without cost, to any shareholder of the Converting Entity or any member of the Converted Entity.

**SIXTH:** In lieu of providing a certificate of account status from the Texas Comptroller of Public Accounts, the Converted Entity will be liable for the payment of any franchise taxes.

**SEVENTH:** This document becomes effective when it is accepted and filed by the Secretary of State.


