NOW, THEREFORE, for good and valuable consideration, as set forth herein by and between the Parties, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignor hereby assigns to Assignee all Assignor's right, title, and interest in and to the Mark and Registration, together with the goodwill of the business symbolized by the Mark and Registration, and all rights to damages and profits, due or accrued, arising out of past infringements of said Mark and Registration, and the right to sue for and recover the same.

2. Assignor shall promptly, upon the request of Assignee, execute such other documents and/or instruments of assignment, transfer and conveyance as Assignee may reasonably request to permit Assignee to record the assignment made by this instrument or any other documents Assignee may reasonably deem necessary or advisable to effectuate the terms and intent of this Trademark Assignment.
