**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT (this "Release") is made as of September 30, 2019, by SUNTRUST BANK, in its capacity as Administrative Agent ("Administrative Agent") for the benefit of the Secured Parties (as defined in the Security Agreement, defined below). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Zelis Network Solutions, LLC, a Georgia limited liability company (f/k/a Stratose, LLC) ("Zelis Network Solutions"), HFN, LLC, an Illinois limited liability company ("HFN"), Zelis Payments, Inc., a Delaware corporation (f/k/a Pay-Plus Solutions, Inc.) ("Zelis Payments"), Zelis Claims Integrity, Inc., a Delaware corporation (f/k/a Premier Healthcare Exchange, Inc.) ("Zelis Claims Integrity"), GlobalCare, Inc., a Georgia corporation ("GlobalCare" and together with Zelis Network Solutions, HFN, Zelis Payments and Zelis Claims Integrity, the "Grantors"), and Administrative Agent are parties to that certain Trademark Security Agreement dated as of January 26, 2016 (the "Security Agreement") pursuant to which each Grantor granted to Administrative Agent a security interest in their respective Trademark Collateral as security for certain obligations owing by such Grantor to Administrative Agent, including the Trademark Collateral set forth on Schedule I hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on January 26, 2016, at Reel 5715, Frame 0977;

WHEREAS, each Grantor has requested that Administrative Agent, and Administrative Agent now desires to, terminate and release its lien on and security interest in such Grantor's Trademark Collateral and reassign any and all rights in the same to such Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Administrative Agent, on behalf of itself and the Secured Parties, hereby automatically and unconditionally terminates the Security Agreement, and discharges, releases, cancels and terminates its lien on and security interest in all of each Grantor's right, title and interest in and to the applicable Trademark Collateral granted pursuant to the Security Agreement, including the applicable Trademark Collateral set forth on Schedule I hereto.

2. Administrative Agent, on behalf of itself and the Secured Parties, hereby fully reassigns, grants and conveys to the applicable Grantor, any and all of Administrative Agent's right, title and interest in and to the Trademark Collateral of such Grantor, including all goodwill connected therewith and symbolized thereby.

3. This Release shall be governed by the internal laws of the State of New York.

4. Administrative Agent hereby authorizes and requests the recordation of this Release with the United States Patent and Trademark Office and any other applicable registry.
