**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT (this "Release") is made as of September 30, 2019, by SUNTRUST BANK, in its capacity as Administrative Agent ("Administrative Agent") for the benefit of the Secured Parties (as defined in the Security Agreement, defined below). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, EthiCare Advisors, Inc., a Nevada corporation ("Grantor"), and Administrative Agent are parties to that certain Trademark Security Agreement dated as of March 23, 2018 (the "Security Agreement") pursuant to which Grantor granted to Administrative Agent a security interest in its Trademark Collateral as security for certain obligations owing by Grantor to Administrative Agent, including the Trademark Collateral set forth on Schedule I hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on March 23, 2018, at Reel 6298, Frame 0576;

WHEREAS, Grantor has requested that Administrative Agent, and Administrative Agent now desires to, terminate and release its lien on and security interest in the Trademark Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Administrative Agent, on behalf of itself and the Secured Parties, hereby automatically and unconditionally terminates the Security Agreement, and discharges, releases, cancels and terminates its lien on and security interest in all of Grantor's right, title and interest in and to the Trademark Collateral granted pursuant to the Security Agreement, including the Trademark Collateral set forth on Schedule I hereto.

2. Administrative Agent, on behalf of itself and the Secured Parties, hereby fully reassigns, grants and conveys to the Grantor, any and all of Secured Party's right, title and interest in and to the Trademark Collateral, including all goodwill connected therewith and symbolized thereby.

3. This Release shall be governed by the internal laws of the State of New York.

4. Administrative Agent hereby authorizes and requests the recordation of this Release with the United States Patent and Trademark Office and any other applicable registry.
