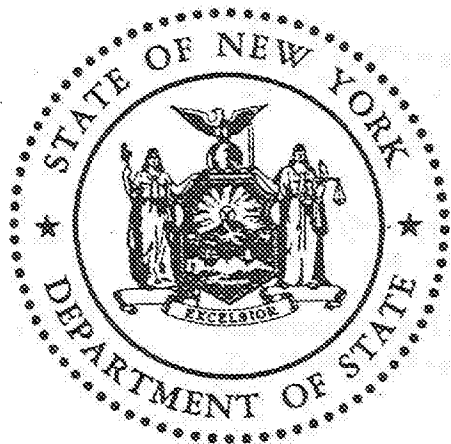

It is hereby certified upon behalf of each of the constituent corporations herein named, as follows:

FIRST: The Board of Directors of each of the constituent corporations has duly adopted a plan of merger setting forth the terms and conditions of the merger of said corporations.

SECOND: The name of the constituent corporation which is to be the surviving corporation, and which is hereinafter sometimes referred to as the "surviving constituent corporation", is CALMAC CORP., a New York corporation.

The date upon which its certificate of incorporation was filed by the Department of State is June 17, 2015.

THIRD: The name of the other constituent corporation, which is being merged into the surviving constituent corporation, and which is hereinafter sometimes referred to as the "merged constituent corporation," is CALMAC MANUFACTURING CORPORATION, a New York corporation, originally incorporated and formerly known as JET-HEET, INC.

The date upon which its certificate of incorporation was filed by the Department of State is March 22, 1947.

FOURTH: A copy of the plan of merger outlining the material features thereof has been given, by mail, to all holders of shares of each subsidiary corporation to be merged not owned by the parent corporation, on August 27, 2015.

FIFTH: The surviving constituent corporation owns 26,544.30 of the 29,486.77 outstanding shares of the merged constituent corporation, which constitutes ninety percent of the outstanding shares of each class of the merged constituent corporation. Pursuant to section 905 of the Business Corporation Law, the Board of Directors of the surviving constituent corporation approved the merger without the express authorization of the shareholders of either of the constituent corporations.

SIXTH: The merger herein certified was authorized in respect of the surviving constituent corporation by the unanimous written consent of the board of directors of each of the constituent corporations.

SEVENTH: The effective date of the merger herein certified shall be the date of filing of this certificate.
