**AMENDMENT NO. 5 TO  
SECURITY INTEREST  
IN PATENTS AND TRADEMARKS**

THIS AMENDMENT NO. 5 TO SECURITY INTEREST IN PATENTS AND TRADEMARKS (this “**Amendment**”), effective as of October 3, 2019, amends the Security Interest in Patents and Trademarks dated as of November 19, 2015, made by Pulse Health LLC, an Oregon limited liability company (the “**Grantor**”), and recorded with the United States Patent and Trademark Office on November 25, 2015, as amended by an Amendment No. 1 to Security Interest in Patents and Trademarks dated as of November 22, 2016, and recorded with the United States Patent and Trademark Office on November 28, 2016; and as amended by an Amendment No. 2 to Security Interest in Patents and Trademarks dated as of March 17, 2017, and recorded with the United States Patent and Trademark Office on March 17, 2017; and as amended by an Amendment No. 3 to Security Interest in Patents and Trademarks dated as of June 1, 2017, and recorded with the United States Patent and Trademark Office on June 5, 2017; and as amended by an Amendment No. 4 to Security Interest in Patents and Trademarks dated as of September 8, 2017, and recorded with the United States Patent and Trademark Office on September 11, 2017 (as amended, the “**Security Interest**”). Capitalized terms used and not otherwise defined herein have the meanings given to such terms in the Security Interest.

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, the Grantor hereby agrees as follows:

1. Exhibit A to the Security Interest is hereby amended by adding the persons and legal entities listed on Exhibit A attached hereto as Grantees. For the avoidance of doubt, the Grantor hereby grants to such persons and legal entities a security interest in (i) all of the Grantor’s right, title and interest in and to the Marks; (ii) all of the Grantor’s right, title and interest in and to the Patents; (iii) all “proceeds” (as such term is defined in the Agreement) of the Marks and Patents; (iv) the goodwill of the businesses with which the Marks are associated; and (v) all causes of action arising prior to or after the date hereof for infringement of any of the Marks and Patents or unfair competition regarding the same.

2. Schedule A to the Security Interest is hereby amended and restated to read in its entirety as Schedule A attached hereto.


3. Schedule B to the Security Interest is hereby amended and restated to read in its entirety as Schedule B attached hereto.
