## INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement is entered into as of October 4, 2019, by and among WHEATON BANK & TRUST COMPANY N.A. (the "Bank"), B-O-F CORPORATION, an Illinois corporation ("BOF"), and JP MANAGEMENT COMPANY, an Illinois corporation ("JP" and, together with BOF, jointly and severally, the "Borrowers", and each, individually, a "Borrower").

### RECITALS

The Bank has agreed to make certain advances of money and to extend certain financial accommodations to the Borrowers under that certain Amended and Restated Loan and Security Agreement by and among the Bank and the Borrowers, and the other parties from time to time party thereto, dated as of October 4, 2019 (as amended, supplemented or otherwise modified from time to time, the "Loan Agreement"). Pursuant to the terms of the Loan Agreement, the Borrowers have granted to the Bank a security interest in its personal property constituting Collateral. Capitalized terms used but not defined herein are used as defined in the Loan Agreement.

NOW, THEREFORE, the Borrowers and the Bank agree as follows:

### AGREEMENT

To secure its obligations under the Loan Agreement and under any other agreement now existing or hereafter arising between the Borrowers, the Bank and any other Borrower, the Borrowers grant to the Bank, a security interest in all of the Borrowers' right, title and interest in, their Intellectual Property (including without limitation those copyrights, patents and trademarks listed on Exhibit A hereto) and all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof.






