E-Vape, “**Assignors**”), and Vapor Finance LLC, a Delaware limited liability company located at 5201 Interchange Way, Louisville, Kentucky 40202 c/o Turning Point Brands, Inc. (“**Company**”), is executed on July 19, 2019.

- A. Assignors are the owners of the trademarks and service marks listed on Schedule A (the “**Marks**”). Technologies is the owner of U.S. Patent Application No. 15/640,417 titled “Mixing Device for Nicotine and Flavoring,” filed June 30, 2017 (the “**Patent Application**”).
- B. Technologies owns and has a bona fide intent to use the trademark or service mark applied for on an Intent-to-Use basis (the “**ITU Mark**”) in interstate commerce. Company desires to acquire the business of Technologies in connection with which Technologies has a bona fide intent to use the ITU Mark and the pending Application.
- C. Assignors assigned the Marks and the Patent Application to Company pursuant to the Asset Purchase Agreement between Assignors and Company as of the same date. This Assignment is executed for recordation with the United States Patent and Trademark Office.

In consideration of the above recitals and the promises set forth in this Assignment, the parties agree as follows:

1. **Trademarks.** Assignors transfer and assign to Company all of Assignors’ right, title and interest in and to the Marks, together with all associated good will and all related rights, including that portion of Technologies’ business in connection with which it has a bona fide intent to use the ITU Mark, and all registrations and applications for registration of the Marks in the United States and any foreign countries, including any renewals and extensions of any registration that is or may be secured, and including all rights of Assignor to sue and recover for any past, present or future infringement, dilution, damage or injury of the Marks and collect profits or damages with respect to the same.
2. **Patent Application.** Technologies transfers and assigns to Company all of Technologies’ right, title and interest in and to the Patent Application and all registrations and applications for registration of the Patent Application in the United States and any foreign countries, including any renewals and extensions of any registered patent, or any divisional, continuation, continuation-in-part or other patent application which might be filed in the United States or in foreign countries which claims priority from the Patent Application, and including all rights of

Technologies to sue and recover for any past, present or future infringement and collect profits or damages with respect to the same.

3. **General.** The provisions of this Assignment inure to the benefit of Company, its successors, assigns and other legal representatives, and are binding upon Assignors, their successors, assigns and other legal representatives.
