RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT ("Release"), dated as of September 30, 2019, is made by **FIFTH THIRD BANK**, an Ohio banking corporation ("Lender"), and is as follows:

WHEREAS, PARTICLE DYNAMICS INTERNATIONAL, LLC, a Delaware limited liability company ("Borrower"), and Lender are parties to that certain Intellectual Property Security Agreement, dated as of June 2, 2010, which was recorded with the United States Patent and Trademark Office on June 11, 2010 in its records at Reel 024523, Frame 0674 (Patents) and recorded with the United States Patent and Trademark Office on June 11, 2010 in its records at Reel 4223, Frame 0599 (Trademarks), as amended by a First Amendment to Intellectual Property Security Agreement, dated as of May 26, 2017, which was recorded with the United States Patent and Trademark Office on May 31, 2017 in its records at Reel 042642, Frame 0214 (Patents) and recorded with the United States Patent and Trademark Office on May 31, 2017 in its records at Reel 6073, Frame 0638 (Trademarks) (the "Agreement"); capitalized terms used but not defined herein will have the meaning given to them in the Agreement;

WHEREAS, the Agreement granted to Lender a security interest in all of Borrower's right, title and interest in and to all of its Trademarks and Patents, including, without limitation: (a) all of Borrower's right, title and interest in and to all of its now or in the future owned or existing Trademarks and Patents listed on Schedule I of the Agreement (attached hereto and made a part hereof as Schedule I); (b) all renewals of each of the Trademarks and Patents; (c) all income, royalties, damages and payments now and in the future due or payable under or with respect to any and all Trademarks and Patents, including damages and payments for past or future infringements of any and all Trademarks and Patents; (d) all rights to sue for past, present and future infringements of any and all Trademarks and Patents; (e) all rights corresponding to each of the Trademarks and Patents throughout the world; (f) all rights of Borrower as licensor or licensee under, and with respect to, trademarks, service marks, trade names, and trademark and service mark applications, including the Trademark Licenses; and (g) together in each case with the goodwill of Borrower's business connected with the use of, and symbolized by, the foregoing; and

WHEREAS, Lender desires to release its rights and security interests in the Trademarks and Patents and terminate the Agreement.

NOW, THEREFORE, Lender hereby releases and terminates (i) its security interest and other rights in, to and under the Trademarks and Patents and (ii) the Agreement and any and all rights it may have thereunder.
