AMENDED AND RESTATED CERTIFICATE OF INCORPORATION

General Corporation Law of the State of Delaware)

WhitePages, Inc. (the "**Corporation**"), a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware (the "**General Corporation Law**"), does hereby certify as follows:

1. The name of this Corporation is WhitePages, Inc.
2. This Corporation was originally incorporated pursuant to the General Corporation Law on August 5, 2005 under the name "WhitePages.com, Inc."
3. The Board of Directors of this corporation, acting in accordance with the provisions of Sections 141 and 242 of the General Corporation Law, adopted resolutions amending and restating Article I of the Amended and Restated Certificate of Incorporation of this Corporation, as amended, to read as follows:

"ARTICLE I

The name of the Corporation is Ekata, Inc. (the "**Corporation**")."
