ASSIGNMENT

For the avoidance of doubt, the "Assets" shall include but are not limited to the inventory, accounts receivable, work in process, supplies, customer lists, trademarks, copyrights, patents, intellectual property of any type, software, motor vehicles, equipment, furnishings, computers, printers, employee contracts, and contracts, including but not limited to the Hartford Insurance Business Owner's Policy #81SBAPR7560.
- 2) **Excluded Assets.** Pursuant to this Assignment, Assignor is not transferring, and Assignee is not receiving, any of Assignor's cash, commercial paper, certificates of deposit and other bank deposits, treasury bills and all other cash equivalents and third person checks deposited or held in Assignor's accounts that have not yet cleared (the "**Excluded Assets**"), all of which shall be retained by Assignor.
- 3) **Cooperation.** Assignor and Assignee agree that following the execution of this Assignment, they shall fully cooperate in the execution and processing of whatever additional documentation is necessary to transfer the Assets to Assignee.
- 4) **Counterparts.** This Assignment may be executed in any number of counterparts, each of which shall be deemed to be an original, and all counterparts, when taken together, will constitute one and the same Agreement.


