PARTIAL RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS PARTIAL RELEASE OF SECURITY INTERESTS IN TRADEMARKS ("Partial Release") is made as of this 30th day of September, 2019, by Goldman Sachs Specialty Lending Group, L.P., as Collateral Agent ("Goldman"), in favor of Il Fornaio (America) LLC (formerly known as Il Fornaio (America) Corporation), a Delaware limited liability company (the "Company") and acknowledged by Company and CBC Restaurant Corp. ("CBC").

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Goldman hereby releases all liens and security interests granted by Company in favor of Goldman in the trademarks listed on Schedule A attached hereto pursuant to that certain Trademark Security Agreement, dated as of November 10, 2017, executed by Company and CBC in favor of Goldman and recorded with the United States Patent and Trademark Office on November 10, 2017 at Reel/Frame 6202/0080 ("Trademark Security Agreement"). For the avoidance of doubt, this Partial Release shall not release, waive, or otherwise modify Goldman's liens and security interests in any trademarks listed on the Trademark Security Agreement that are not hereby expressly released pursuant to this Partial Release. From and after the date hereof, Company shall cease to be a party to the Trademark Security Agreement, but the Trademark Security Agreement will remain in full force and effect between CBC and Goldman as modified hereby.

This Partial Release may be executed in any number of counterparts, each of which when so executed and delivered shall constitute an original, but all of which shall constitute a single contract. It shall not be necessary in making proof of this Partial Release to produce or account for more than one such counterpart. Delivery of an executed counterpart of a signature page of this Partial Release by telecopy or other electronic imaging means shall be effective as delivery of a manually executed counterpart of this Partial Release.


