## ASSIGNMENT OF TRADEMARKS

WHEREAS, Assignor desires to transfer to Assignee and Assignee desires to acquire from Assignor all of Assignor's right, title and interest in and to the Trademark, together with the benefit of any use of the Trademark by the Assignor, and the goodwill of the business relations thereto and to the wares or services associated with it, in exchange for Fifty (50%) Percent of the issued and outstanding stocks of the Assignee; and

NOW THEREFORE, the parties agree as follows:


1. Upon the terms and subject to the conditions of this agreement, Assignor, for good and valuable consideration, consisting of ten (\$10) United States dollars and other consideration, the receipt and sufficiency of which is hereby acknowledged, hereby sells, transfers, conveys and assigns unto Assignee
  - (a) the entire right, title and interest in and to the Trademark, together with the goodwill of the business in connection with which it is used and which is symbolized by the Trademark, and
  - (b) all registrations and applications for registration, if any, of the Trademark within the United States including, without limitation, those specifically hereinbefore identified, and
  - (c) the right to recover for past infringement within the United States of the Trademark.
2. Assignor agrees to execute any further papers as are necessary, and to take any and all further action as is reasonably requested by Assignee, to convey the Trademark and other property and rights intended to be conveyed hereby to Assignee and to secure Assignee of the full and complete enjoyment thereof.

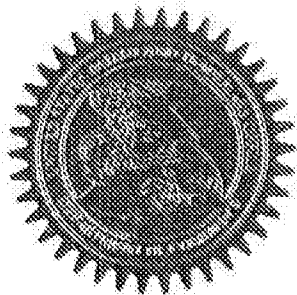
