**TERMINATION AND RELEASE OF SECURITY INTEREST IN  
TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Termination and Release"), dated as of October 11, 2019, is made by **BANK OF AMERICA, N.A.**, as Administrative Agent (in such capacity, the "Agent"), in favor of the Grantors listed on Schedule I hereof (collectively, the "Grantors" and each, individually, a "Grantor"). Unless otherwise defined herein, capitalized terms used in this Termination and Release shall have the meanings assigned to such terms in the Security Agreement (as defined below).

**WHEREAS**, the Grantors and the Agent entered into (i) that certain Trademark Security Agreement, dated as of March 22, 2019, recorded at Reel 6598, Frame 0401 in the Trademark Division of the United States Patent and Trademark Office (the "USPTO") on March 22, 2019 (the "Trademark Security Agreement") and (ii) that certain First Supplement to Trademark Security Agreement, dated as of July 26, 2019, recorded at Reel 6712, Frame 0246 in the USPTO on August 5, 2019 (the "First Supplement" and, together with the Trademark Security Agreement, the "Trademark Grants").

**WHEREAS**, pursuant to (i) that certain Security and Pledge Agreement, dated as of March 22, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), by and among the "Grantors" party thereto from time to time and the Agent and (ii) the Trademark Grants, the Grantors pledged and granted to the Agent a security interest in and continuing lien on all of the Grantors' right, title and interest in, to and under the Trademarks, including those trademarks and trademark applications listed on Exhibit A attached hereto;

**WHEREAS**, the Agent has agreed to terminate, release and discharge its security interest and lien on all of the Trademarks.

**NOW, THEREFORE**, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities of the Grantors secured by the Trademarks pursuant to the Security Agreement and the Trademark Grants, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent hereby terminates, releases and discharges all of its mortgages, liens, and security interests in all of the Grantors' right, title and interest in, to and under the Trademarks and hereby reassigns any and all such right, title and interest (if any) that the Agent may have in the Trademarks to the Grantors.

2. The Agent authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Termination.

3. THIS TERMINATION AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS TERMINATION SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK, WITHOUT

REGARD TO CONFLICTS OF LAW PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION.
