## **RELEASE OF SECURITY INTEREST IN TRADEMARK**

This RELEASE OF SECURITY INTEREST IN TRADEMARK is given as of this 1st day of October, 2019 by WEBSTER BUSINESS CREDIT CORPORATION, a New York corporation (“WBCC”) individually, as lender and as agent for itself and each other Lender Party (WBCC, acting in both capacities, herein called “Lender”), in favor of HDS TRADING CORP. and VHF REALTY, LLC (each, a “Company” and, collectively, “Companies”), as follows:

**WHEREAS**, pursuant to that certain Trademark Security Agreement dated as of March 5, 2014 (the “Security Agreement”) between the Companies and Lender, the Companies granted to Lender a security interest in and continuing lien (the “Security Interest”) upon any and all right, title and interest of Company in and to all of the following now owned or hereafter adopted or acquired by the Company: (i) all trademarks, trade names, trade styles, service marks, logos, other source identifiers, prints and labels on which any of the foregoing have appeared or appear, registrations and recordings thereof, and all applications in connection therewith, including all registrations, recordings and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State or Territory thereof, or any other country or any political subdivision thereof, (ii) all reissues, extensions or renewals thereof; (iii) all goodwill associated with or symbolized by any of the foregoing, (iv) including the trademarks set forth on Schedule A attached hereto (the “Trademarks”); and

**WHEREAS**, the Security Agreement was recorded with the United States Patent and Trademark Office on April 10, 2014 at Reel 5257, Frame No. 0861; and

**WHEREAS**, Lender desires to release its Security Interest in and upon the Trademarks.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby releases its Security Interest in and upon the Trademarks and assigns any and all interest that it may have in the Trademarks to the Companies (each without any representation, recourse or undertaking by the Lender). To the extent Lender retains any interest in or to the Trademarks, Lender hereby assigns, transfers and conveys to each Company all of Lender’s right, title, and interest that it may have, whether by assignment or otherwise, in, to, and under any continuing security interest in the Trademarks, including without limitation its entire right, title and interest in, to, and under the trademarks set forth on Schedule A.
